#### Terms and Conditions

1.1. When accessing or using the "adbelem" website ("adbelem" or "Site"), including the contents and applications available on the Site and in other domains used to operate adbelem, the person who accesses or uses the Site ("User") declares to have read and understood these Terms of Use ("Terms"), as well as fully and expressly agreed with them and to be bound to unrestrictedly comply with the conditions set forth herein, forming a contract between the User and the Assembly of God Bethlehem Minister - USA .

1.2. The User declares to be of legal age and capable, having full conditions to adhere and be bound by the conditions of these Terms.

1.3. If the User does not understand or does not agree with any provision of these Terms (in whole or in part) or does not have the legal capacity to contract, on his own behalf, the User must immediately leave adbelem.org, close the tab or window of the Internet browser that you are using to access it and refrain from accessing or otherwise using adbelem.org.

1.4. The User acknowledges and agrees that all notices, usage regulations, policies and instructions presented on adbelem.org, especially the Privacy Policy, are part of these Terms, as if they were transcribed therein.

1.5. Assembly of God Bethlehem Ministry – USA may modify these Terms at any time, and the User, by accessing and/or using adbelem.org, will express his/her consent and full agreement to comply with such modifications or revisions. The User must periodically reread the current version of this instrument (available at the URL <u>http://www.adbelem.org/</u>), although the Assembly of God Bethlehem Ministry – USA always seeks to keep the User informed of important changes made to these Terms.

1.6. The present Term will enter into force at the time of the first access or use of adbelem.org by the User and will remain in force for the period necessary for the integrated compliance with these Terms.

1.7. Financial Contributions & Donations:

All contributions and donations are final and no refunds will be issued.

2. Account on adbelem.org

2.1. The provisions of this clause 2 will be applicable if adbelem.org makes available to Users an account for access to a restricted area or for certain features of the Site.

2.2. The User may create an account to have a more personalized experience on the Site. Access credentials, including login and password, are personal and non-transferable.

2.3. When creating an account, the User declares that the information provided is correct, complete, current and true. It is the User's responsibility to keep personal information up-to-date, correct, complete and truthful in the Assembly of God Bethlehem Ministry – USA database.

2.4. The User is solely responsible for the activity that takes place on his account and must keep his access credentials in a safe place, with the User being solely responsible for their confidentiality. The User must immediately notify the Assembly of God Bethlehem Ministry – USA of any possible breach of security or unauthorized use of their account, being responsible for the acts carried out through it, until their correct communication to the Assembly of God Bethlehem Ministry – USA.

2.5. The User agrees that Assembly of God Bethlehem Ministry – USA, at its sole discretion, may cancel or suspend its account or part of the functionalities related to it, without prior notice:

(a) by discontinuing or modifying the Site or any of its parts;

- (b) by acts of God or force majeure;
- (c) for security reasons;

(d) as a result of a court order or legal request from a competent authority;

(e) if the User fails to comply or acts in a way that clearly shows that he does not intend or cannot comply with any condition of these Terms, other regulations applicable to adbelem.org or current legislation; and

(f) if the User terminates his relationship with the Assembly of God Bethlehem Ministry – USA or the User wishes to delete his account, having previously notified the Assembly of God Bethlehem Ministry – USA, at any time.

2.6. The User's readmission decision will represent a mere act of liberality by the Assembly of God Bethlehem Ministry – USA, not representing, under any circumstances, any change to the provisions of these Terms. Likewise, the User's readmission will not represent the agreement of the Assembly of God Bethlehem Ministry – USA with the action or omission that resulted in the User's termination, remaining all the User's obligations regarding the use of the Site's account.

# 3. Use of adbelem.org

3.1. The Assembly of God Bethlehem Ministry – USA grants personal, non-exclusive and non-transferable permission to the User to access and use adbelem.org in a lawful manner, having access to the entire collection of images, illustrations, audios, audiovisuals, texts, applications, databases and other materials available on adbelem.org ("Contents"). On the other hand, the User undertakes not to:

(a) reproduce or in any way copy, transmit, exploit or distribute the Contents of adbelem.org, in whole or in part, for any purpose (including text, images and other materials), without the

prior written authorization of the Assembly of God Bethlehem Ministry - USA;

(b) alter or modify any part of adbelem.org or any of the Content;

(c) access the Contents through any technology other than the display pages of adbelem.org itself or any other means authorized by the Assembly of God Bethlehem Ministry – USA;

(d) perform or participate in any activity that interferes or interrupts the operation of the Site or the equipment, computer programs and/or services to which adbelem.org is connected;

(e) upload, transmit, disseminate, display, send or in any way make available any type of message, advertisement, advertisement or promotional material not previously authorized by the Assembly of God Bethlehem Ministry – USA, in writing, or unsolicited messages (known as such as "junk mail" or "spam"), chain letters, pyramid schemes or others;

(f) use any automated system, including but not limited to "robots", that access adbelem.org in a manner that sends more requests for access or use in a given period than is humanly possible to respond to in the same period of time. User agrees not to collect any Content or information that identifies any person, including names, account credentials, or other personal data, from the Site;

(g) act in a way that harms the Assembly of God Bethlehem Ministry - USA or third parties;

(h) use adbelem.org for any purpose other than private and informational access to the Site, nor approach another adbelem.org user for any commercial purpose;

(i) decode, decompile or reverse engineer to obtain source code, information and/or other features of adbelem.org and/or the Contents;

(j) perform any act that may expose third parties in a derogatory way, create or share content (i) false, illegal, abusive, that incites violence, crime or practice that may affect the health or safety of people, or (ii) ) of a defamatory, racist, homophobic, obscene, pornographic, immoral, political, partisan or commercial nature, or (iii) that may violate the morals, ethics, good customs or rights of the Assembly of God Bethlehem Ministry – USA or third parties ;

(k) comply with these Terms, Privacy Policy and all applicable laws and regulations, whether regional, national or international.

3.2. Assembly of God Bethlehem Ministry – USA reserves the right to suspend, cancel or discontinue any Content, application or access to adbelem.org at any time, without prior notice to anyone.

3.3. Links to external websites that may be cited on adbelem.org do not represent any kind of endorsement of these external websites or their content by Assembly of God Bethlehem Ministry – USA. Any access to or use of these external websites by the User will be at his/her own risk. The Assembly of God Bethlehem Ministry – USA is also not responsible if the

3.4. In addition to the above general restrictions, the following conditions apply specifically to the use of the Contents:

3.6. If the Assembly of God Bethlehem Ministry – USA makes Content available on adbelem.org with the option of downloading or printing, such Content may be used solely by the User, on a non-exclusive, non-transferable basis, only for reference and without any commercial connotation, being any reproduction, distribution, transmission, exhibition, licensing or any other form of transfer, use or exploitation, in whole or in part, of these Contents is prohibited, without the prior written consent of Assembly of God Bethlehem Ministry – USA.

### 4. User Manifestations

4.1. The provisions of this section apply to any content, questions, comments or other manifestations ("Manifestations) that the User may share with adbelem.org or publish on the Site.

4.2. The User will be fully responsible for the Manifestations that they share or publish, in their content, substance, veracity and other aspects, as well as in the compliance of these Manifestations with the provisions of these Terms, the Assembly of God Bethlehem Ministry – USA and adbelem.org being exempt of any liability.

4.3. By sharing or publishing a Manifestation, the User (a) expressly declares and guarantees that he/she is the sole owner of all copyright, image, privacy or any other rights over the Manifestation; and (b) licenses to the Assembly of God Bethlehem Ministry – USA the Manifestation, free of charge, irrevocable, irreversible, for the entire period of legal protection of the rights incorporated in the Manifestation, for the territory of Brazil and abroad, and the Assembly of God Bethlehem Ministry – USA use, publish, distribute, translate and make available such Manifestation on adbelem.org, on social networks and other channels used by adbelem.org, in print, including but not limited to books and periodicals, or any support that allows the reproduction of the Manifestation, existing or that will be created in the future, without restriction as to the number of reproductions, vehicles, fixation support, term, territory and form of exploitation.

4.4. As a consequence of the provisions of the previous clause, the views of the Manifestation on adbelem.org may be measured and computed in favor of the Site.

4.5. The User declares and acknowledges that the publication or sharing of any Manifestation may give rise to its misuse by third parties, without any authorization from the Assembly of God Bethlehem Ministry - USA, the publication or sharing being at the User's exclusive risk, without the Assembly of God Bethlehem Ministry – USA bears any responsibility.

4.6. If the Manifestation is published on adbelem.org or on its social networks or communication channels, the Assembly of God Bethlehem Ministry – USA will attribute the respective credits in the form in which they are provided by the User.

4.7. adbelem.org may, at its sole discretion, exclude any Manifestation, regardless of prior notice to the User and without the User having any right to indemnification, response, new manifestation or any consideration due to the exclusion of the Manifestation.

### 5. Notice of Infringement of Rights

5.1. In case of violation of any regulation applicable to adbelem.org or if the User suspects a violation of rights or inappropriate content such as, but not limited to, copyright infringement, obscene material, hate speech, shocking and disgusting images , dangerous and illegal acts or defamatory material, the User must immediately notify the Assembly of God Bethlehem Ministry – USA for analysis and possible removal of the allegedly irregular content. 5.2. It is necessary to identify the declaring User, through his full name and other personal contact data.

5.3. Any person who intentionally makes a false or incorrect statement about Content will be subject to legally applicable penalties, and may also have their access to adbelem.org blocked, suspended or discontinued.

### 6. Responsibilities and Warranties

6.1. 6.2. The Assembly of God Bethlehem Ministry – USA does not guarantee the availability, continuity or infallibility of adbelem.org and/or its Contents, nor that they are free from flaws, errors, inaccuracies. adbelem.org and its Content are provided for informational purposes and do not present any guarantee or promise, implicit or explicit, of performance, or even of estimation of success or correctness. Furthermore, the User is aware that when using the Site, he may be exposed to content that is inaccurate or offensive, despite all efforts by Assembly of God Bethlehem Ministry – USA to the contrary.

6.3. 6.5. The User agrees to defend, indemnify and hold harmless the Assembly of God Bethlehem Ministry – USA, its partners, sponsors, partners, executives, professionals, representatives and third parties from any and all lawsuits or administrative proceedings, in order to obtain satisfaction for damages. , liabilities, losses, costs or debts (including, but not limited to, attorneys' fees) arising from: (a) improper use of or access to adbelem.org and/or the Content; (b) violation of any provision of these Terms, other regulations applicable to adbelem.org or applicable law; (c) violation of any third party rights, including but not limited to intellectual property or privacy rights; or (d) any claim that any act performed by the User has caused loss or damage to third parties. This obligation will survive the expiration of these Terms and your use of the Site.

6.6. The Assembly of God Bethlehem Ministry – USA makes no warranty of any kind, express, implied or of any other nature, and will not be responsible for the usefulness and suitability of adbelem.org for any specific purpose or need of the User or third parties. for the purpose of expanding Biblical knowledge in the word of God.

# 7. General Provisions

7.1. Communications to the Assembly of God Bethlehem Ministry – USA referred to in these Terms or relating to adbelem.org should be addressed to the 'Contact' section available on the Site.

7.2. Regardless of notice, the Assembly of God Bethlehem Ministry – USA may reveal any data relating to the User and eventual Manifestation to public authorities, in compliance with a court order or other competent authority, or legal duty.

7.3. These Terms and any limited rights to use the Content granted hereunder may not be transferred or assigned by the User, but may be transferred, assigned or revoked by Assembly of God Bethlehem Ministry – USA, without any restriction.

7.4. The names, slogans, domain names and/or brands of Assembly of God Bethlehem Ministry – USA and its sponsors and partners cannot be used by the User, and any alteration, insertion or modification in these identifiers is also prohibited.

7.5. If any provision of these Terms is held by competent authority to be invalid or ineffective, the invalidity or ineffectiveness of such provision will not affect the validity or effectiveness of the remaining provisions, which will remain in full force and effect.

7.6. Any waiver of the exercise of rights arising from these Terms shall not be considered

novation, additional or continued waiver of this or any other right, and the failure on the part of Assembly of God Bethlehem Ministry – USA not to enforce any right or clause of these Terms shall not constitute a waiver or novation of such right or clause.

7.7. In the event of a conflict between these Terms and the adbelem.org Privacy Policy, the provisions of the Privacy Policy will prevail. If there is a conflict between the provisions of these Terms and any other regulation, notice, policy or regulation of this Site, the provisions of these Terms will prevail.

7.8. These Terms and the existing relations between the User and the Assembly of God Bethlehem Ministry – USA will be governed by the laws of the Federative Republic of Brazil and the current laws of the United States of America, without regard to any provision on conflict of laws.

7.9. The User agrees that: (i) the headquarters of adbelem.org will be considered exclusively that of the Assembly of God Bethlehem Ministry – USA, located in the city of Lighthouse Point - Florida, United States of America - USA; To resolve any doubts or questions arising from these Terms, waiving any other, however privileged it may be.
